~~members~~ of said corporation called for the purpose of amending the articles of incorporation, and held on the fifth day of December, 1959,

it was resolved by the vote of ~~the holders of shares~~ MAJORITY OF MEMBERS of each class entitled to vote [a majority of the members]

that Article No. II of the Articles of Incorporation is amended to read as follows, viz.:

ARTICLE II

The purpose or purposes for which the corporation is formed are as follows:

To own, acquire, purchase, construct, repair, operate, and in general to maintain and provide garbage and trash removal and disposal service and sewage disposal and treatment services and equipment of all nature appropriate or necessary for providing such services; to own, hold and manage in conformity with the restrictions upon the use and occupation of said real estate, any lot or lots or other real estate which it may acquire by purchase or otherwise for the common use and benefit of the owners of lots in Upper Long Lake Estates subdivision, according to the plat thereof recorded in Liber 75, Page 42 of plats, Oakland County Records, and in Upper Long Lake Estates No. 1 Subdivision, according to the Plat thereof recorded in Liber 81, Pages 8 and 9, Oakland County Records, and to do all things in connection with the ownership of said lot or lots which shall seem to the Board of Directors of this corporation to be beneficial and in the best interests of all owners of all lots in said subdivision, including, but not by way of limitation, the right to impose reasonable regulations governing the use of said lots, and in general to act in association for the protection, improvement and betterment of all lots contained in said subdivision; to establish reasonable charges and rates for all services to be rendered, including, but not by way of limitation for the use to be made of any property, real or personal, owned or possessed by the corporation; in general, to take all action and do all things necessary or appropriate to carry out the foregoing purposes.
