- Boat owners, in "good standing" with all fees, who were assigned a slip in the prior year, are eligible for a slip in the current year.
- Resident homeowners must be in "good standing", all dues paid all years of residency, to enter or remain on wait list
- Only written application requests, by homeowners, will be accepted and honored for dock space wait list.
- Dock spaces are reserved in the date order that applications are received.
- If a space becomes available and you turn it down, you will forfeit your space on the wait list
- If you don't have a boat when space becomes available, you will have 3 weeks to comply or forfeit to next on list
- Wait list position or boat slips cannot be assigned and rights do not transfer with change of property ownership.
- Boats qualifying for dock space must be currently registered and insured in the name of the homeowner.
- The 2016 one-time dock entrance fee (1st time slip assignees) is \$500. This fee goes toward maintenance & preservation of the docks.
- 2016 C dock fee is \$200, C Group Launch fee is \$75. Both are required for boat slip.
- ULLE Association dues (\$90) are a prerequisite and in addition to dock fees and C access fees (\$90,\$200,\$75=\$365)
- Payment of the C Access fee entitles the resident to a key for the gate lock. Locks are changed annually.
- Residents who use dock space are expected to keep the area clean of debris and free of any potential safety hazards.
- Due to the limited number of boat slips, currently only C Group residents are eligible to use or wait list the C Docks.
- All watercraft must be launched from Lot 64/C Group Launch and the C Group Resident Launch Use agreement must be signed
- Lot 64/Group C Boat Docking Application and Boat Docking Policies and Procedures are provided with slip assignment.
